TACKLE FOOTBALL PROGRAM INFORMATION

The Oregon Recreation and Jerusalem Township Recreation Departments would like to welcome you and your child to the **2021 tackle football season! We will be having 3rd&4th AND 5th&6th Grade Tackle this season!**

Program Information: REUNITED!! We are very proud to announce that through the cooperation of the Clay High School and Fassett Jr. High School football coaches, Maumee Bay Turf Football (“Turf Nation”) and the Oregon Rec Dept, we have formed the Oregon Youth Football Committee and have come to an agreement to merge our tackle football programs. Having the athletes playing together and coming up together through this new program is ultimately the best way to enhance the Oregon football community and culture. We have made it our priority to provide a program with **HIGH QUALITY COACHING** in an environment **for ALL athletes** to develop and for the program to **compete at the HIGHEST level!** We are excited that coach Derek Besgrove, Dave Ostrander, Tony Katschke, and Jim Besgrove will continue with our program this season and will be heading up the 5th&6th Grade program. We will be holding interviews on July 17(times TBD) for 3rd&4th Grade coaches, and possibly for more 5th&6th grade coaches depending on what our numbers look like after registration. We will be returning to the NWOYFL (Northwest Ohio Youth Football League) this year as they have a 3rd&4th Grade division.

Registration Dates: Registration runs from June 16 and ends on July 15.

The program is open to Oregon residents, Jerusalem Township residents, and non-resident students enrolled in the Oregon Public School System or Cardinal Stritch School for the 2021-2022 school year.

Register at www.oregonohiorec.com click “register”. Or print out registration under “forms” and return with payment to Oregon Rec drop box or office at 5330 Seaman Rd. Metal building with blue metal roof in the rear of the municipal complex.

Registration Fee Information: There is a fee structure on the registration form based on residency and free and reduced lunch program. There is a \$10 late fee if you register after the deadline but before the coaches’ meeting. After the coaches’ meeting, you will be placed on a waiting list. We will look at the teams to see if there is room on a team for your child. If there is room on a team, the late fee will be \$20, and your child will be placed on the team with the least amount of players regardless of school.

Uniform/Equipment Information: Your child will be provided with a helmet and shoulder pads. All players will also receive a game jersey, game pants, practice jersey and practice pants. **Helmets, shoulder pads and practice jerseys will be returned at end of season.** ***Players must provide an athletic supporter and mouth guard. They also must wear all protective equipment when playing. *** Equipment, jersey/pant sizing will be **Tues July 20, 5:30-8PM at Rec office. PLEASE BRING THE FOLLOWING TO THE SIZING:** **1.** Copy of **birth certificate.** **2.** A **grade card/progress** report, or copy thereof, from this past school year. **3.** A **current photo** of athlete. **if you cannot, or forget, you can bring these to the rec office at your earliest convenience, but before season starts Sept. 12. **These are requirements of the NWOYFL** and coaches must have these in binders at every game.

Practices and Game Information: **Non-mandatory practice/skills camps will start mid-July (date/time TBD)** and **mandatory practice will start early August (date/time TBD).** Games will be on Sundays starting Sept. 12. Home games will be played at Clay HS stadium. Practices will be held at Clay Highschool, north of the stadium.

5. By signing this Release, I will be forever prevented from suing or otherwise claiming against the Releasee for any property loss or personal injury that I may sustain while participating in or preparing for the above noted activity.

6. I understand that this Waiver and Release Agreement is binding on me, my spouse, my heirs, my executor, my administrator, personal representatives, and assigns.
