### 2021 Fall 3<sup>rd</sup> thru 6<sup>th</sup> grade CHEERLEADING PROGRAM INFORMATION

The Oregon Recreation and Jerusalem Township Recreation Departments would like to welcome you and your child to the 2021 cheerleading season. **Go EAGLES!!!!**

**Program Information:** This is a “pep squad” program for our **3<sup>rd</sup>&4<sup>th</sup>, 5<sup>th</sup>&6<sup>th</sup> grade** tackle football program. There will be no lifts, flips, or other stunting taught in this program. The participants will learn the basic requirements of leading cheers and cheering for games. The program will be led by current Clay High School cheerleaders with adult supervision. Due to time commitments of team games and practices for each sport, players will not be able to play in other sport programs during this season.

**Registration Information:** Registration opens on July 14 and ends on August 10 .

The program is open to Oregon residents, Jerusalem Township residents, and non-resident students enrolled in the Oregon Public School System or Cardinal Stritch School for the 2021-2022 school year.

Or print out registration under “forms” and return with payment to Oregon Rec drop box or office at 5330 Seaman Rd. Metal building with blue metal roof in the rear of the municipal complex. Office hours 8AM-4:30PM (lunch 12:30-1PM) Mon-Fri. Drop box available 24/7.

**Registration Fee Information:** There is a fee structure on the registration form based on residency and free and reduced lunch program. There is a \$10 late fee if you register after the deadline but before the coaches’ meeting. After the coaches’ meeting, you will be placed on a waiting list. We will look at the teams to see if there is room on a team for your child. If there is room on a team, the late fee will be \$20, and your child will be placed on the team with the least amount of players regardless of school.

**Uniform/Equipment Information:** Your child will be provided with a T-shirt, sweatshirt, and Poms. *\*\*\*If your child needs a different size than originally ordered, you will be responsible for the cost.\*\*\**

**Practice/Game Information:** **Practices** will be held **once a week** on the same day (TBD) **from 6:30-8PM**. Location TBD. Games start September 12. Once the game schedule is set, it is given to the cheer coach. Parents will then be notified by the coach in regard to the games the squad will cheer at. **Only the HOME games will be cheered at.**

**Parents’ Meeting Information:** Parent’s meeting will be held **Tues Aug 17<sup>th</sup> at 6PM**. **Location TBD**. We will send out an alert to all registrants with location once it is determined.

5. By signing this Release, I will be forever prevented from suing or otherwise claiming against the Releasee for any property loss or personal injury that I may sustain while participating in or preparing for the above noted activity.

6. I understand that this Waiver and Release Agreement is binding on me, my spouse, my heirs, my executor, my administrator, personal representatives, and assigns.
