



2021 FALL NFL FLAG FOOTBALL REC DIVISION PROGRAM INFORMATION

The Oregon Recreation, Jerusalem Township Recreation and **Genoa Rec** Departments would like to welcome you and your child to the 2021 flag football season. **NEW THIS SEASON!!** We will be playing games in Genoa and at the Oregon Rec. This will provide a travel element to the league, while at the same time not requiring very much travel time. We are excited about this merger and continuing to enhance the Flag Football experience for the athletes!

Program Information: Oregon Recreation is a member of the NFL Flag Football! This provides our players with NFL replica jerseys and provides coaches access to online training materials and play books. Leagues are based on your child's grade for the 2021-2022 school year: 1st & 2nd Graders, 3rd & 4th Graders and 5th & 6th Graders.

Players currently in grades 1st thru 6th are eligible to participate in flag football. Will be using NFL Flag rules.

Due to time commitments of team games and practices for each sport, players will not be able to play in other sport programs during the season.

Registration Information: Registration runs from July 1 and ends on Aug 8.

The program is open to Oregon residents, Jerusalem Township residents, Genoa residents and non-resident students enrolled in the Oregon Public School System or Genoa Public Schools, or Cardinal Stritch School for the 2021-2022 school year.

Registration Fee Information: There is a fee structure on the registration form based on residency and free and reduced lunch program. There is a \$10 late fee if you register after the deadline but before the coaches' meeting. After the coaches' meeting, you will be placed on a waiting list. We will look at the teams to see if there is room on a team for your child. If there is room on a team, the late fee will be \$20, and your child will be placed on the team with the least amount of players regardless of school.

Uniform/Equipment Information: Your child will be provided with an NFL replica jersey & a set of flags.

*Players must provide a mouth guard. Rubber cleats are optional. *

Game Information: Game schedule will be contingent upon availability of officials and working around any coaches' conflicts. Games could be played during the week and/or on weekends. Look to start Sept. 12

Coaches' Meeting Information: The coaches' meeting will be Tuesday Aug. 10 at 6PM in city council chambers. This is for coaches only. 5. By signing this Release, I will be forever prevented from suing or otherwise claiming against the Releasee for any property loss or personal injury that I may sustain while participating in or preparing for the above noted activity.
6. I understand that this Waiver and Release Agreement is binding on me, my spouse, my heirs, my executor, my administrator, personal representatives, and assigns.
