



Eagles Youth Basketball!!!!

The Oregon Parks and Recreation and Jerusalem Recreation Departments, along with Joel Visser (Clay HS boys basketball coach), and Keith Kennedy (Clay HS girls basketball coach) welcome you to the Eagles Youth Basketball season!!! This program will have three divisions, 1st & 2nd grade, 3rd & 4th grade, and 5th & 6th grade. 1st & 2nd grades will be co-ed teams. 3rd thru 6th grade teams will be separated into boys' and girls' teams. Girls team may play in the boys division if we don't have enough athletes for separate boys and girls divisions. 1st & 2nd grade division uses an 8 ft rim, and 3rd & 4th a 9ft rim, and 5th & 6th a 10 ft rim. **1st & 2nd grade will be run as a basketball academy** where all the athletes train together working on drills and fundamental development of skills; and then on Sundays will play games against each other on teams that the academy coaches have formed.

Program is open to Oregon residents, Jerusalem Township residents, and non-resident students enrolled in the Oregon Public School System or Cardinal Stritch Academy and Northwood students. (Please note a different fee structure is in place for eligible non-residents. See registration form for details.)

Registration dates: Registration runs from Sept 15, 2021, to Oct 7, 2021. If you register after teams are formed, you will be placed on a waiting list and only placed on a team if there is an opening. The team you will be placed on will be the team with the lowest number, not necessarily the school you attend.

All eligible participants can register two ways: 1) Online at www.oregonohiorec.com. Click the "register" link. Or, on the same website click on "forms", print out the Eagles Youth Basketball registration form, complete it and return with payment to our beige drop box outside of the ORec office. 5330 Seaman Rd Oregon Oh 43616. We are behind complex in metal building with blue meta roof. Drop box available 24hrs/day.

Non-Residents- All non-residents, whether attending Oregon City Schools or not, will **select the non-resident fee.**

Registration Fee Information: There is a fee structure on the registration form based on residency and free and reduced lunch program. **NOTE** OREGON FREE and REDUCED fee eligibility is based on last school year 2019-20, not this school year.** *Stritch does not cover this fee. * There is a \$10 late fee if you register after the deadline, and your child will be placed on the team with the least amount of players regardless of school. If there is not room for your child on a team, you will be placed on a waitlist, and we will advise you should a place on a roster open.

Uniforms: Each athlete will be provided with a reversible jersey, and shorts.

Games/Practices: All age groups will play games starting **Oct 31** and ending **Dec 19, 2021.** Season will conclude with a tournament, OR position games. Games will be played on **Sundays** at **Clay High School gymnasium**, starting late morning running until mid/late afternoon. **Practice times for 3rd thru 6th grade** teams will be based on coaches' and gym availability. **1st & 2nd grade academy** will have one or two practices per week always on the same days. **Academy days/times TBD. ****If needed we may play a few weeknight games to fulfill a full game schedule.**

Interested in Coaching?? Submit information on the registration. **Coaches meeting will be Tues Oct 12 at 6PM** at ORec offices and teams will be formed based on players ratings. **NOTE** On Sat Oct 9 at 1:30-3:30PM** at Clay HS there will be a player assessment/rating clinic **for all 3rd-6th grade participants.** There will then be a **coach training clinic Sun Oct 17 at 3-5PM** at Clay HS for all program coaches looking to increase coaching knowledge and insight.
